## What Can You Donate?

### Only usable items – no trash please

<b>Men's /boy's clothing</b>	Pakistani and western style
<b>Women's clothing</b>	Only Pakistani style
<b>Winter clothing</b>	Coats, jackets, sweatshirts for men, women, boys, and girls
<b>Bicycles (any size)</b>	And children's Toys (no electronics please)
<b>Foot wear</b>	Shoes, sneakers, boots – men, women and children – all sizes
<b>School supplies</b>	Educational books, elementary and middle school text books, backpacks, note books, ball point pens, pencils, and calculators
<b>Household items</b>	Pots, pans, dishes, tents, tarps, blankets/comforters, sleeping bags, sheets
<b>Medical equipment</b>	Crutches, wheelchairs, braces, splints, walking canes, reading glasses
<b>Miscellaneous items</b>	Computers, laptops, printers, sturdy small and medium packing boxes with lids

## How to pack these items?

- Use HEAVY DUTY, 1mm Thick "Compactor" Trash Bags, (the kind that do not rip easily) for clothing, and soft items
- Do not bring loose items
- Put hard items such as toys, tools, and other items that would poke through a bag into sturdy boxes with lids. Do not seal or tape the boxes shut.
- Keep pairs of shoes separate in their own bags. If shoes have laces, tie them together, otherwise put a rubber-band around the shoes to keep the pairs together.
- Ladies shalwar-kameez suits should be rolled up as a set and secured with a rubber band
